Understanding the Impacts of Community Development Investments on Resident Health:

Downtown Kansas City, KS

The goal of this exercise was to record resident perceptions on: 1) Visible community development improvements; 2) Potential community health improvements; 3) Recognized community events/programs/agencies/leaders; and 4) Areas of opportunity. Participant comments were recorded as written or dictated, and categorized using colored Post-It notes related to the four domains listed above.

What community development opportunity should be focused on next?

1 The Wyandotte Towers building at 915 Washington Boulevard is currently being assessed with consideration to redistribute residents into a Choice Neighborhoods Program that supports locally driven strategies to transform distressed HUD housing and addresses the challenges in the surrounding neighborhood. This is preferred as it "puts residents into community houses rather than concentrating them in one location."

Earlier this year, Prairie Fire Development brought to the Unified Government a proposal to build a 92-unit, mixed-income apartment project that would be flanked by an urban agriculture center. The complex would be located at 8th St. and Washington Blvd., near the Healthy Campus. DTS was told that they were a "first time applicant and that they should try again in the future."

- The city is discussing the removal of the north leg of the downtown freeway loop, the Lewis and Clark Viaduct and convert it into a parkway or pedestrian/transit-way park connecting downtown KCK to downtown KCMO.
- 4 A Bike Route is being developed in the area through local residents.
- 5 There is a privately-owned property at the corner Huron Park along 6th Street which was the location of a historic hotel. Some residents have expresses an interest to see it support a small band event space to incorporate a Street Blues Festival. 6 There are plans to extend the Complete Streets project between 8th to 10th Streets.
- Many would like to see water fountains, water resources for dog-walkers, improvements to the rose gardens and lighting for the pavilion structure in Huron Park.
- 8 The empty school building, Central Elementary (813 Barnett Avenue), needs attention. It's "emptiness is noticeable." Could it be redeveloped as an apartment building?
- The 9th and Armstrong Avenue Apartment building is boarded up. Could it be renovated?
- 10 Rob Richardson is currently working with a firm out of Chicago called Camiros to develop a Northeast Area Master Plan.

Where has there been a recent project or improvement in your neighborhood?

- 1 Sumner Academy has received a grant to renovate their football field LISC supported a study that created the Self-supported
- Municipal Improvement District (SSMID), which was initiated in 2008 and has provided the following: availability of Security Ambassadors; provides Cleaning Ambassadors; replaced trash receptacles and updated Banners and is contracted with the UG. This is a self-imposed property tax among business and property owners in this District (ends west of 12th Street as those property owners felt they were getting the needed services. In this area, there "seems to be a cultural difference" where these business owners don't understand the benefit of this program.) It has "increased walkability and reduced trash in the district." The Community Ambassadors are liaisons with the police and with their training, they are able to connect people with
- social services when needed. 3 The UG, through the DTS, contracted with inSITE Planning, LLC and Rosin Preservation, LLC to conduct an intensive "Historic Resources Survey" of the commercial, civic, and institutional resources that comprise Downtown Kansas City, KS along the two, primary east-west streets, Minnesota and State Avenues/5th to 18th Streets.
- 4 The Environmental Protection Agency (EPA) building is currently vacant. There have been various discussions about how to bring in some new user. The UG owns the parking lot across from the street, along Minnesota Avenue, and is scheduled for renovation.
- 5 The DTS supports the Sixth Street Arts Corridor with the Kansas City Cupcake Co., Epic Clay Studio (CHWC), Epic Park (CHWC) as "assets/partners."
- 6 St. John's Park is developing a dog park through the Strawberry Hill Neighborhood Association.
- 7 There have been recent developments along Central Avenue: SLAPS BBQ and the Splitlog Coffee restaurant. There is an apartments/retail project being planned in the

- 8 The Frank Williams Center (1201 N 7th St) is a homeless day shelter that was closed and re-opened in 2016 under a new operator, Wyandot Inc.
- 9 The Willa Gill Soup Kitchen (645 Nebraska Avenue) provides hot lunches and services through Mount Carmel Church. 10 The 7th Street Casino (777 N. 7th Street Traffic-way) has
- invested a fair amount in improving the building and area surrounding it. 11 Huron Cemetery has suffered from vandalism.
- 12 The Duschene Clinic (636 Tauromee Avenue) is a valued 'safety-net' clinic for local residents. 14 Bishop Ward Academy (708 N 18th Street) is an asset in the
- 15 Boiler Makers Union (753 State Avenue) is a headquarters
- Bank of Labor Brotherhood Bank. 16 The YMCA is being planned to move from 8th Street to the
- Big Eleven Park area. 17 The Children's Campus with Project Eagle (KU, LISC, United Way supported) is an edu-care facility that provides high quality childcare and preschool.
